## 1. Defined Terms

The following are the terms and conditions for becoming an Exhibitor at 2017 Tallahassee Comic Con. The term "Event" means Tallahassee Comic Con, currently scheduled for December 2 & 3, 2017 ("Event Dates") at the Tallahassee Automobile Museum ("Event Facility"). The Event is owned, produced, and managed by Tallahassee Comic Con Inc. As used hereinafter, the term "Organizer" means, collectively, TCC Inc and each of its/their respective officers, directors, agents, affiliates, representatives, employees and assigns unless the context requires otherwise. The term "Exhibitor" means, collectively the company, any other business entity, or person that applied for exhibit space rental and agreed to enter into this contract.

## 2. Contract Acceptance

This contract shall become binding and effective only when it has been signed below by Exhibitor.

## 3. Assumptions of Risks; Releases

Exhibitor shall on a current basis, indemnify, defend, and hold Organizer and the Event Facility harmless from any and all claims, demands, suits, liabilities, damages, losses, costs, reasonable attorneys' fees and expenses, which result from or arise out of or in connection with Exhibitors' participation or presence at the Event; any breach by Exhibitor of any agreements, promises or other obligations under this contract; any matter for which Exhibitor is otherwise responsible under the terms of this contract; any violation or infringement of any law or ordinance or the rights of any party under any patent, copyright, trademark, trade secret or other proprietary right; any libel, slander, defamation or similar claims resulting from the actions of Exhibitor; harm or injury (including death) to Exhibitor; and loss or damage to property or the business or profits of Exhibitor, whether caused by negligence, intentional act, accident, act of God, theft, mysterious disappearance or otherwise. Exhibitor shall not settle or compromise any claims against Organizer without Organizer's prior written consent.

## 4. Refund / Cancellation Policy

Should you (the Exhibitor) find that you are not able to attend Tallahassee Comic Con 2017 and have already paid for your booth(s), the policy is as follows:

Refund requested before September 1, 2017 – 100% refunded

Refund requested before November 1, 2017 – 50% refunded

**\*\*NOTE\*\* ANY CANCELLATION OF BOOTH/TABLE AFTER NOVEMBER 1, 2017 WILL RESULT IN THE FORFEITURE OF ANY AND ALL PAYMENTS MADE TO TALLAHASSEE COMIC CON.**

## 5. Assignment of Space

Exhibit space shall be assigned by TCC Inc in its sole discretion for the Event and for the Event Dates only. Any such assignment does not imply that similar space will be assigned for future events held by Organizer. TCC Inc reserves the right to change the floor plan or to move an Exhibitor to another booth location prior to or during the Event if TCC Inc in its sole discretion determines that to do so is in the best interest of the Event.

### AGE RESTRICTED ITEMS

Age-Restricted Items are defined by Organizer as items that have an age restriction, such as M-Rated Video Games / R-Rated Movies, "Adult" Graphic Novels, Comics, Manga and/or Books, Vapes or E-Cigs, and Live or real weapons. Graphic images and titles must not be visible (i.e., depictions of nudity or sexual content must be covered) or displayed in such a way that it cannot be viewed by minors or from the aisle. Exhibitors are required to check ID of anyone interested in viewing and/or purchasing these items, and all items sold in accordance with any applicable law.

### PROHIBITED ITEMS

- Any drug-related paraphernalia or illegal substances
- Live-action pornographic materials of any sort
- "Bootleg" or non-licensed reproductions of any copyrighted material
- Federally controlled items such as tobacco, alcohol, firearms, and "adult toys"

Any Exhibitors selling these items will be given a warning by Event staff, and will be asked to remove the items from the premises. If the Exhibitor fails to comply, they will be permanently banned from any and all TCC Inc events. No table refund will be given.
